Maintenance & Renewal Criteria

TMCA Credentialed Distinguished Mediator

Maintenance and Renewal of TMCA Credentialed Distinguished Mediator Status –

In order to maintain TMCA Credentialed Distinguished Mediator status, mediators must meet the following standards and renew their designation by January 1st of each year.

- (1) Annually conduct a minimum of 25 mediations or 150 hours mediation experience.
- (2) Annually complete 15 hours continuing education which meets TMCA criteria for continuing education. This must include 3 hours of ethics in mediation. Click [here](#) for Continuing Education criteria.
- (3) Make him/herself available to the courts and/or to the public to conduct 5 *pro-bono* mediations annually.
- (4) Complete a renewal form and pay the renewal fee of \$150.00 due January 1st of each year. Click [here](#) for the Renewal form.

TMCA Credentialed Advanced Mediator

Maintenance and Renewal of TMCA Credentialed Advanced Mediator Status In

order to maintain TMCA Credentialed Advanced Mediator status, mediators must meet the following standards and renew their designation by January 1st of each year.

- (1) Annually conduct a minimum of 10 mediations or 60 hours mediation experience.
- (2) Annually complete 15 hours continuing education which meets TMCA criteria for continuing education. This must include 3 hours of ethics in mediation. Click [here](#) for Continuing Education criteria.
- (3) Make him/herself available to the courts and/or to the public to conduct 2 *pro-bono* mediations annually.
- (4) Complete a renewal form and pay the renewal fee of \$125.00 due January 1st of each year. Click [here](#) for the Renewal form.

TMCA Credentialed Mediator

Maintenance and Renewal of TMCA Credentialed Mediator Status – In order to maintain TMCA Credentialed Mediator status, mediators must meet the following standards and renew their designation by January 1st of each year.

- (1) Annually conduct a minimum of 3 mediations or 15 hours of mediation experience.
- (2) Annually complete 15 hours continuing education which meets TMCA criteria for continuing education. This must include 3 hours of ethics in mediation. Click [here](#) for Continuing Education criteria.
- (3) Complete a renewal form and pay the renewal fee of \$100.00 due January 1st of each year. Click [here](#) for the Renewal form.

TMCA Candidate for Credentialed Mediator

Maintenance and Renewal of TMCA Candidate Credentialed Mediator Status – In order to maintain TMCA Candidate Credentialed Mediator status, mediators must meet the following standards and renew their designation by January 1st of each year.

- (1) Annually complete 15 hours continuing education which meets TMCA criteria for continuing education. This must include 3 hours of ethics in mediation. Click [here](#) for Continuing Education criteria.
- (2) Candidate status may be maintained for a maximum of four years in order to allow the candidate time to complete the requirements for TMCA Credentialed Mediator.
- (3) Complete a renewal form and pay the renewal fee of \$50.00 due January 1st of each year. Click [here](#) for the Renewal form.
